The cost of class will be \$60 per person and if 30 miles or more from our residence the cost will be \$70 per person. The area to shoot must be safe and not in any violation of a local ordinance. We do not want to get the class ticketed for Disturbing the Peace by Loud Noise (bang) and/or Illegal Possession of Firearm. We usually will come out to see how safe the area is before we set up class date. We have already held a couple of these types of courses and it worked out very well. It was actually a comfortable and relaxing training environment. By doing this, we are able to continue to help our clients and also acquire new ones. ## **LOUISIANA 2017 LEGISLATION SESSION**

To the best of our knowledge, we cannot find any Bills directly related to civilian carrying concealed handguns. Which is a good thing. There are a couple of Bills that are related to allow certain group of First Responders (Paramedics, EMTs, Firefighters I and Firefighters II) to carry concealed while on duty and while traveling to and from work. As for as we are concerned if those type of individuals already have a current CCH permit, it is up to their employer or jurisdiction if they allow a holder of

that permit to carry while employed. There is one thing that closely effects the outcome of these Bills if they are passed, the employers or department they work for could have policy that keeps them from carrying concealed while working, like many businesses and departments already have.

It is a good Bill but it should state that their employer or department allows them to carry concealed while working. They don't allow the Bill to include that then the bill is kind of moot. House Bill #68 (HB68) and House Bill #186 (HB186). Representative Ivey, from Baton Rouge district is author of HB68. He is a young Representative and is a strong supporter of carrying concealed.
